igration has been part of human history ever since the evolution of mankind. Early people migrated from one place to another in search of better food and safer shelter from predators and natural calamities. Migration Report', the International Organization for Migration (IOM), notes that today more than 281 million people live in a country other than their place of birth. To put this figure in perspective, the number of global migrants is more than the entire population of Indonesia — the fourth most populated country in the world.

In recent years the slew of Insinuations, imputations, and accusations against migrants in the media has led to migrants being perceived in a negative light by many in the host country. Discussions in social and political circles on migrants and migration, often center on how migrants are a drain on national resources and a threat to internal security.

Parliament dissolved, specific articles of constitution suspended

is Highness the Amir Sheikh Mishaal Al-Ahmad Al Sabah on Friday 11 May, decreed the "dissolution of the National Assembly and the suspension of certain articles of the Constitution for a period not exceeding four years. The decree added that during this period a thorough review of the democratic process in the country will be undertaken and recommendations submitted to His Highness the Amir for further consideration.

In a televised address to the nation on Friday, His Highness the Amir stated:

"My dear countrymen, during the recent period, Kuwait has faced challenging times that



have had repercussions at all levels, leading to a negative reality. As stewards of this country and its loyal people, we endeavored to provide advice and guidance to navigate through these circumstances with minimal losses. Unfortunately, we encountered insurmountable difficulties and obstacles, "This leaves us with no choice but to make the difficult decision to save our country, secure its highest interests, and safeguard the capabilities of our loyal people, who deserve utmost appreciation and respect."

"Dear people of my country, democratic governance, as a way of life and work, imposes a high degree of responsibility on public authorities and the clear delineation of their roles within a vision that aims for achievement.

"This vision mandates numerous checks on legislative and executive authorities to ensure their adherence to its provisions. These checks are absolute and cannot be altered or evaded. No party or authority can deviate from them, criticize them within its factions, or attempt to circumvent them. ""During past periods, and even just a few days ago, we witnessed behaviors and actions that contradicted established constitutional principles.ome individuals made threats and pledged to initiate inquiries just to reinstate a minister to their position.

"Others objected to the nomination of certain individuals, either out of forgetfulness, ignorance, or deliberate intent, disregarding the fact that the selection of the prime minister and their cabinet members is an exclusive constitutional prerogative of the head of state. No one should breach its boundaries, encroach upon its jurisdiction, or meddle within its domain

I must also emphasize that the sources of national wealth should not be neglected or exploited in a manner that depletes their resources and undermines the nation's interests through proposals that squander public funds and fail to serve the public good.

"Everyone must understand that no one is exempt from the law. Those who illicitly acquire public funds will face consequences, irrespective of their position or authority. I will never permit democracy to be manipulated to undermine the state, as the well-being of the people of Kuwait, which supersedes all other concerns, is entrusted to us. It is our responsibility to safeguard and defend these interests.

Just as our predecessors were committed to fortifying its principles and passing its legacy to us, our duty and commitment are to pass on the torch of democracy to future generations, proudly soaring in our nation's skies,"

"I cannot overlook the actions of certain governments that have committed serious violations and transgressions due to parliamentary pressure or misguided and ineffective efforts, resulting in a negative impact on the public interest. This has led to convicted individuals of treason being set free due to these unacceptable practices. I will never allow such occurrences to repeat under any circumstances."

"A warm greeting to the security personnel who safeguard the interests of the people and bear the responsibility of maintaining security in our country. Their dedication ensures that citizens can rest peacefully, knowing that their security and freedom are being watched over.

"Allow me to be frank: Respect for security personnel is tantamount to respect for the government, and I will not tolerate any compromise to their prestige and respect while they carry out their official duties," His Highness the Amir added in conclusion.

Kuwait emerges as vibrant hub for Nepali job seekers

The relations between the two countries have blossomed, resulting in substantial advancements across aviation, transportation, tourism, and business sectors.

uwait is emerging as a vibrant hub for employment of Nepali nationals, and bilateral relations between Nepal and Kuwait are flourishing. This relationship has yielded significant mutual benefits in various sectors, including aviation, transportation, tourism, and business.

In this context it is valid to examine the coordination and implementation of Kuwait's regulatory body regarding Nepali workers and employment. In 2020, Nepal's Ministry of Labor acknowledged that inter-agency coordination is a primary priority and challenge, calling for a reduction in incoordination among various government agencies. Poor coordination directly impacts workers. An example of such is the signing of significant bilateral labor agreements without planning for diplomatic missions' establishment. The Department of Foreign Employment's ability and efficiency to investigate within the country have long been a concern, with its capacity being disproportionately low compared to identified cases of fraud in Nepal's recruitment industry.

A new agreement between the Department of Foreign Employment and the Police in 2020 was significant. Until then, apart from trafficking cases, migrant workers could not register labor fraud cases at the Foreign Employment Department in Kathmandu, which had a limited workforce and was far for workers to reach.

The labor agreement empowered the police to refer cases related to agencies to the Foreign Employment Department and investigate all other worker-related and unregistered recruitment agency cases. Corruption has greatly hindered the Department of Foreign Employment's investigative capabilities, directly impacting workers' benefits. Several senior officials have faced repeated arrests for allegedly accepting bribes from recruitment agencies to remove them from the government's blacklist.

In recent times, a close relationship has developed between Kuwaiti and Nepali citizens. The Nepali embassy in Kuwait has also highlighted Nepalese interest in Kuwait's manmade physical infrastructures like the Kuwait Tower and the 32 km Al-Jaber Bridge above the sea, although these are not tourist attractions.

Analysts suggest maintaining a strong, harmonious, and vibrant relationship between the two countries is crucial. Moreover, creating a conducive environment for the supply of petroleum products in Nepal is believed to benefit millions of Nepalis. Kuwait's travel operators have also worked to promote Nepal's natural heritage, culture, tradition, and tourism. Nepal views the support and cooperation between the two countries as a significant milestone for the Nepali people.

Recently, there has been growing government interest in combating corruption related to job creation for migrant workers, especially as instances of human trafficking linked to job creation corruption have surfaced. However, due to uncertainties regarding action against high-ranking officials, there remains ambiguity regarding the government's dedication to addressing such practices.

Recommendation to the government of Nepal:

Based on relevant provisions of the Foreigners Act (FAA), it is recommended



to implement the zero-cost immigration model and fully impose fines on job creation organizations that charge more than the legal limit.

- Increase the number of employees and ensure they receive effective training to significantly enhance the research capacity of the Foreign Employment Department
- Following the signing of the 2020 DOFE-Nepal Police Agreement, enhancing cooperation between DOFE and the police administration will ensure police involvement in addressing fraud and abuse is strengthened.
- Allocate more resources to investigate and prosecute corruption within DOFE. Annually disclose information on identified corruption cases publicly, recommend


cases of corruption to the police administration, and hold accountable officials accused of soliciting or accepting illegal payments in government immigration programs.

Suggestions for the Kuwaiti government:

- Continuously enhance the capacity of labor inspectors to identify serious violations, including non-payment of wages, in employment creation practices. Ensure necessary resources, language proficiency, and research skills for conducting personal interviews with workers during visits.
- Significantly improve public oversight of human resources in job creation organizations to accurately assess worker protection efforts. Require private

- employer organizations to transparently report on worker grievances and pay fees.
- Arrange labor inspections at private residences where domestic workers reside, including unannounced visits.
- Adopt active investigation, including criminal prosecution when there is sufficient evidence, in cases of corrupt practices and human discrimination related to job creation by employers and job creation organizations.
- By coordinating with ministries in Nepal and engaging in discussions with Kuwaiti dignitaries, journalists, employers, and tourism businessmen, the Nepali embassy aims to strengthen relations between the two countries. This will foster goodwill and lead to stronger ties between the two

Qatar to provide 200MW of power to Kuwait's national-grid

atar has granted approval to the request by Kuwait's Ministry of Electricity, Water, and Renewable Energy (MEW) to provide Kuwait with 200 megawatts of power in June. This increases Kuwait's total energy import from the Gulf Electricity Interconnection Project to 500 megawatts, following Oman's earlier approval

for 300 megawatts.

The ministry received approval from the Gulf Interconnection Authority regarding Qatar's agreement to supply Kuwait with 200 megawatts during June, which can be renewed for the months of July and August, subject to the conditions of the Qatari and Kuwaiti networks.

The additional 500MW would help MEW to overcome the challenges of the summer. It is expected that the Gulf Interconnection Authority will sign purchase agreements with the Sultanate of Oman and Qatar in the coming days, according to what was agreed upon between the concerned parties.

he unified Gulf Cooperation Council (GCC) visa system is expected to be in place by the end of 2024, and will lead to positive outcomes for regional economies.

Speaking on the sidelines of the World Economic Forum, which was held in Riyadh on April 28 and 29, UAE's Minister of Economy, Abdullah bin Touq Al Marri, said the unified regional tourist visas would be called GCC Grand Tours and it will allow tourists to spend more than 30 days in the six countries that make up the GCC.

"Once it comes into effect, it will make travel to our region more convenient and affordable for tourists, and will contribute to highlighting the diverse tourism destinations in GCC countries, attracting and retaining tourists for longer periods, thus increasing the number of hotel guests and making the region one of the leading destinations for regional and international tourists alike," said Al Marri.

The UAE and other Gulf countries are reportedly working with international tourist



operators, and companies to roll out packages that take care of the entire region.

Talks are said to be underway with hotels and airlines to create partnerships. "As a government, we create the right platform that enables them to create business. So we work closely with the private sector to make it happen, " said Al Marri. He added that once the GCC single tourist visa is rolled out, companies and tourist operators will automatically roll out combined packages, including business and leisure packs.

Ministry launches 'Wajod' app for fingerprint verification

 $E^{\text{ducational sources have announced the launch of the}} \\ \text{E}^{\text{'Wajod' application by the Ministry of Education. This}} \\ \text{app enables fingerprint verification using a mobile phone.}$

According to sources speaking to Al-Jarida, the Information Systems Department has fully developed the application, which is compatible with iOS and Android devices. The ministry intends to deploy the app to track attendance and departures for workers in the 'Secondary Control' departments covering scientific, literary, and religious education. The sources elaborated that the application, installed on mobile phones, operates

based on geographical coordinates and is Bluetooth-linked to the fingerprint system. This setup allows 'control' officials to monitor taxpayer attendance and departures, ensure adherence to required



working hours, and identify absentee taxpayers.

The new application's mechanism is expected to address the fingerprint verification challenge faced by teachers assigned to 'control' work, who often encounter difficulties returning to schools to validate their exit fingerprint due to their duties in 'control.'

The government sector experienced a 2.4 percent increase in the number of employees to total about 476,000. While the majority of these employees (80.1%) are citizens, non-Kuwaitis in the public sector accounted for 94,800 workers.

atest data on the labor market in Kuwait provided by the Central Statistical Bureau (CSB) show that in 2023, the Kuwaiti labor market underwent significant changes with approximately 129,000 new entrants, boosting the total workforce to around 2.9 million. This marked a 4.6 percent increase from the 2.79 million workers recorded at the end of 2022.

The private sector continued to employ more than half of Kuwait's workforce, comprising approximately 56.8 percent of total workers, while the government sector accounted for 16.3 percent and the family sector comprising domestic workers accounted for 31.9 percent.

The largest number of Kuwaiti workers continue to be concentrated in the government sector, comprising 80.1 percent of the total workforce in that sector. Their number in the government sector increased from 370,814 individuals in 2022 to 381,208 individuals by December 2023. The largest proportion of non-Kuwaiti workers remains in the private sector, accounting for 64.3 percent, with their numbers increasing by about 84,000 people, to total 1.58 million at the end of 2023.

According to the CSB figures, the number of Kuwaiti workers increased from 442,600 individuals in December 2022 to 454,000 individuals in December 2023, achieving an annual growth rate of 2.6 percent, bringing their total participation in the labor market to 15.6 percent.



Segregation of Kuwaiti workers based on gender shows that the number of Kuwaiti males in the labor market reached 191,200 citizens, while the number of females in the labor market reached 262,800 citizens.

Meanwhile, the number of non-Kuwaiti workers increased from 1.59 million individuals in December 2022 to 1.67 million individuals in December 2023, marking a 5.3 percent increase. Gender wise the number of males reached 1.4 million, while the number of females reached 187,000.

The government sector experienced a 2.4 percent increase in the number of employees to total about 476,000. While the majority of these employees (80.1%) are citizens, non-Kuwaitis in the public sector accounted for 94,800 workers.

The private sector also experienced growth in employee numbers in 2023, increasing by about 84,500 people. This brought the total

number of employees in the private sector to 1.65 million individuals, marking a 5.3 percent increase over the number of workers in the private sector during 2022.

Despite government encouragement, the number of citizens working in the private sector only marked a sluggish increase, going from 71,800 workers at the end of 2022 to 72,800 workers in December 2023, an increase of 1.3 percent. In the meantime, the number of non-Kuwaitis working in the private sector increased by about 156,400 individuals, bringing their total number to 1.656 million workers.

The number of workers in the family sector (domestic helpers) increased by about 33,000 workers during the past year, bringing the total to approximately 786,231 workers. The percentage of workers in the family sector accounted for approximately 31.9 percent of the total workforce in the country.

Over 56.7 percent of national workers in the private sector are focused on three main economic activities: 32.6 percent work in accommodation and food services, 13.1 percent in financial and insurance activities, and 11 percent in construction.

Meanwhile, more than 60.6 percent of non-Kuwaiti workers are engaged in the private sector, specifically in three economic sectors: 36.6 percent in food and accommodation services, 13.8 percent in construction, and 10.2 percent in manufacturing industries.

Segregation based on nationality shows that India continued to top Kuwait's labor market in 2023, with about 30.3 percent of the total workforce, or around 885,400 workers being Indians. Egypt followed in second place with 477,900 workers, accounting for 16.4 percent of the labor market. Kuwaitis ranked third with 454,000 workers, making up 15.6 percent of the labor market.

Filipino workers occupied 9 percent of the Kuwaiti labor market with 262,800 workers, while Bangladesh accounted for 8.5 percent with 249,400 workers. Sri Lanka had a 4.7 percent share, totaling 137,400 workers of the same nationality.

Other countries contributing to the labor pool in appreciable numbers included workers from Nepal, Pakistan, Syria, and Jordan, with 111,000, 70,000, 46,600, and 28,900, respectively.

Kuwait reiterates humanitarian role with visit to Chad refugee camp

Kuwait has reaffirmed its steadfast dedication to supporting humanitarian causes globally, as evidenced by a recent field trip to refugee camps in Chad hosting refugees escaping the conflict in Sudan.

The visit, conducted in collaboration with the United Nations High Commissioner for Refugees (UNHCR), Kuwaiti Ministry of Foreign Affairs, and the Abdullah Al-Nouri Charity Association, aimed to evaluate the urgent needs of the Sudanese refugees

Representative of UNHCR to Kuwait, Nisreen Rubaian, painted a stark picture of the refugee crisis, revealing that 8.5 million people have been displaced within Sudan due to the ongoing conflict. She added that In the past year alone, approximately 100,000 refugees have sought refuge in remote areas of Chad, where basic necessities are severely lacking. "The best way to mobilize support and galvanize action is through direct observation," Rubaian emphasized, underscoring the importance of witnessing first-hand the plight of refugees through the field trip.

The Kuwaiti delegation, led by Hessa Al-Felekawi, director of Development and Cooperation at the Ministry of Foreign Affairs, voiced Kuwait's steadfast backing for humanitarian endeavors.

Al-Felekawi emphasized Kuwait's commitment to upholding its status as a global humanitarian center, drawing inspiration from the legacy of His Highness the late Amir Sheikh Sabah Al-Hamad, a trailblazer in humanitarian efforts. She pointed out, "The participation of the Ministry of Foreign Affairs in this field visit is a resounding message of Kuwait's unwavering commitment to humanitarian causes." The delegation emphasized the critical necessity of relocating 150,000 Sudanese refugees, with 77 percent being women and children, from unsafe zones to safer areas. This relocation is essential to guarantee their safety and welfare.

Ambassador of the Republic of Chad to Kuwait, H.E. Taher Al-Nazzif, expressed his deep gratitude to Kuwait,



the UNHCR, the Ministry of Foreign Affairs, and the Abdullah Al-Nouri Charity Association for their field visit to the refugee camps. He emphasized that this initiative was a direct response to Chad's request for assistance, as the country is struggling to cope with the influx of refugees.

For his part, Chairman of the Board of Directors of the Sheikh Abdullah Al-Nouri Charity Association, Jamal Al-Nouri, discussed the organization's initiatives in aiding refugees in Chad. He disclosed that in mid-May, the association, working alongside the UNHCR, conducted a visit to Chad to evaluate the conditions of around half a million Sudanese refugees living there. He warned that the number of refugees is expected to increase if the situation in Sudan continues to deteriorate,

Al-Nouri praised the Kuwaiti government for its unwavering support, highlighting that it is the primary donor to the association's relief efforts. He also emphasized the transparency measures in place to ensure that aid reaches the intended beneficiaries. "We select our partners from international or local organizations with whom we have been working for years. In addition, there are branches of some Kuwaiti charities, and in some cases, there are auditors if the financial aid is large."

"Kuwait's leadership in humanitarian action serves as an inspiration to others, demonstrating that compassion and support know no borders," Al-Nouri added.

Reusing used tires as industrial fuel

The project aims to achieve a dual benefit by reducing industrial energy usage while also addressing the issue of used tire accumulation, thereby contributing to solving the tire crisis.

n line with initiatives by the government to lower local energy consumption rates, authorities are exploring the utilization of used tires as an alternative energy source to fuel industrial furnaces. This initiative will not only reduce the use of fossil fuels in industries, but also address the issue of safely disposing the millions of used tires that accumulate in Kuwait annually.

The plan involves shredding the used tires and converting them into fuel-quality products that can be used in factory furnaces in place of fossil fuels (oil or coal), which will also significantly benefit the environment.

According to studies on global experience, factories capable of burning solid waste can initially consume alternative fuels at a rate of 40 percent, with the goal of reaching 100 percent within

A related study conducted in 2020 showed there were 2.26 million registered vehicles in Kuwait, including 1.86 million small cars and 364,000 trucks/buses, totaling 9.5 million tires.

The study assumes that if 50 percent of used tires are replaced annually, there will be 4.7 million tires per year, equating to 13,000 tires daily. Using used tires as fuel for factories helps significantly reduce the accumulation of waste tires, with the effectiveness depending on the level of reliance on them.

The tire-shredding process, which began in Kuwait in 2019, has resulted in the shredding of over six million tires within a two-year time period. A new study revealed that the daily production of locally shredded tires amounts to 10,000, totaling 250,000 per month and three million annually. It also highlighted several logistical needs for the success of this trend, which can be summarized in two scenarios.

A recent report by the Environment Public Authority regarding the optimal handling of the used tires storage site in the Salmi area, showed that the issue poses one of the largest challenges for the Authority due to their detrimental impact on the environment and the environmental issues that arise from



their accumulation.

The Environment Agency recommended swift removal and disposal of these damaged and used tires, alongside proposing radical solutions to tackle the problem.

'Kuwait champions moderation and solidarity in foreign policy'

 \mathbf{H} is Excellency Awadal-Karim Al-Rayah Balla, the Sudanese ambassador to the country, affirmed that Kuwait's foreign policy is characterized by moderation and solidarity with its allies. He highlighted Sudan's appreciation for these principles and its keenness on maintaining strong relations with Kuwait. He noted that Kuwait stands out as one of the few countries worldwide that offer support and aid unconditionally, without a political agenda or interference, making it advantageous for engaging in economic projects and assisting countries in need.

His Excellency stated during a press conference with representatives of local media at his residence, "We have witnessed many conflicts and seen Kuwait's mediation in them, emphasizing Kuwait's status as a reconciled country with itself and its surroundings. Therefore, Sudan places great importance on its relations with Kuwait."

Ambassador Al-Rayah Balla pointed out that Sudan was one of the first countries to recognize Kuwait's independence and contributed to its consolidation. In return, Kuwait acknowledged this contribution. Additionally, Sudan was the first country to receive a loan from the Kuwait Fund for Arab Economic Development, specifically for the expansion of the railway in Sudan.

He stated that Kuwait has very large and significant investments in Sudan across various sectors such as agriculture, agricultural processing, animal production, construction projects, and the communications sector. Additionally, there are substantial investments by individuals and companies from Kuwait in Sudan, and the volume of trade exchange before the war reached about 500 million dollars. He highlighted that Kuwait has contributed to large-scale projects that have not only economic but also political dimensions. He also mentioned that Kuwait is Sudan's largest creditor outside the Paris Club, with total Kuwaiti debts to Sudan exceeding 15

The ambassador stated that in 2013, massive development projects took place in Sudan, transforming it from a consumer to an exporter of services such as electricity. This was achieved through the construction of four dams, which increased electricity production and expanded the agricultural area. These efforts helped Sudan move towards achieving Arab food security. He emphasized that these vital projects were supported by Kuwait without any political agenda, aiming only to strengthen the Arab security system and foster bonds of brotherhood and friendship with Arab countries.

His Excellency pointed out that Kuwait supported the "Jeddah Platform," which called for the militia to vacate the civilian objects it



had occupied. This included hospitals, schools, universities, homes, as well as electricity and water facilities. The platform was proposed after more than 1,000 factories were destroyed, along with universities, museums, and public libraries. He stressed that after the Sudanese army successfully eliminated a large portion of the Rapid Support during the first month of the war, the Rapid Support turned to occupying civilian objects. He added, "I say it unequivocally: If it weren't for regional interventions and the involvement of some neighboring countries, this war would have ended in the first month."

Kuwait home to 20,000 Sudanese

Ambassador Al-Rayah Balla mentioned that Kuwait is home to about 20,000 Sudanese and their families, with the majority being doctors, university professors, and accountants, along with some workers in agriculture and herding. The embassy provides them with all necessary services.

He further added, "We currently have a team of five officers from the Ministry of Interior specialized in passport issues. They arrived about a year and a half ago and in approximately four months, they processed around 3,000 passports. This was possible after rebuilding the new passport factory in the new administrative capital in Port Sudan, following the destruction of the old factory in Khartoum by militias." In response to a question about the largest Kuwaiti investments currently affected in Sudan, the ambassador explained, "There is a very large Hilton hotel in the center of Khartoum that is now under the control of

Additionally, the Zain Telecommunications Company suffered significant damage due to the destruction of cables, towers, and stations. I want to commend the company, Zain, because it is one of the few, if not the only one, where thousands of employees continue to receive their full salaries to this day, despite the war continuing for more than a year. Through you, I salute Engineer Badr Al-Kharafi for his humanitarian and noble stance, and for his commitment to keeping the company operational in Sudan despite the immense challenges."

"uwait's population is on the verge 4,913,271, compared to 4,793,568 in January of surpassing five million, currently standing at 4.91 million, marking a rise of approximately 120 thousand compared to figures from a year ago.

A recent statistic from the Central Administration of Statistics showed that the population on January 1, 2024, amounted to

2023. The number of citizens reached 1,545,781, compared to 1,517,760 a year ago, marking an increase of 28,705. As for the number of non-Kuwaitis, it reached 3,367,490, compared to 3,276,492 a year ago, indicating an increase of

The data showed that the number of citizens

is 758,716, with females totaling 787,065 and males outnumbering non-Kuwaitis (2,262,500 compared to 1,104,990).

Youth constitute the overwhelming majority of citizens, with their number reaching about 650,000, distributed across age groups as follows: 135,811 (Aged 20-24), 131,084 (Aged 25-29), 115,946 (Aged 30-34), 105,058 (Aged 35-39), 88,195 (Aged 40-44), and 75,591 (Aged 45-49).

The remaining numbers are distributed as follows, around 650,000 for age groups ranging from less than one year to 19 years old, and approximately 245,000 for age groups from 50 years old to over 80.

Migration supports robust resilient communities

Their presence and practices are seen as infringements on traditional cultures, social mores, and religious values of the host nation.

Migrants are also often blamed for rising criminal activity in society. While it is true that many migrants may follow different faiths or display cultural practices that are at variance from the larger host population, the accusation that migrants are responsible for an increase in law-breaking activities is unfounded. Numerous studies and security records show that migrants are no different than local citizens in this regard.

Migrant remittance volumes are also a source of contention with critics of migration often calling for curbing or taxing foreign remittances. However, proponents point to the multiple benefits that accrue from remittances to both the host country and the recipient nation. Globally, remittance flows are estimated to have reached USD 860 billion in 2023, marking a 3 percent increase from a year earlier.

On average, nearly 7 percent of the annual global remittance amount goes to individuals and entities in host countries as transfer fees, in addition to providing employment to locals and boosting the economy. Also, the estimated \$860 billion remittance in 2023 is likely on the lower side, as it does not account for unofficial transfers. According to the World Bank, global remittances through official channels to Low- and Middle-Income Countries (LMIC) touched \$669 billion in 2023.

Migrant remittances also constitute a significant portion of the GDP of many developing countries, and in some places these transfers now surpass official development assistance (ODA) and foreign direct investment (FDI) flows. In 2023, the top five recipient countries for remittance inflows among LMICs were India (125 billion), Mexico (67 billion), China (50 billion), the Philippines (40 billion), and Egypt (24 billion). India has been the largest recipient of remittances since 2008

Negative perceptions aside, international migration remains one of the main drivers of human development and economic growth worldwide. Most migrants arriving in a new country contribute to the local economy and help build robust, resilient, and productive communities through their input of knowledge, networks, and skills, as well as contributions to social welfare.

Global studies on migration by the World Bank and other entities highlight the net positive impact of migration on the world economy— in 2023 migrants are estimated to have contributed nearly 10 percent of the global GDP. On a more microeconomic level, a 2021 survey by the Boston Consulting Group of senior executives across several countries and industries, found 72 percent of the executives considered migration to benefit their companies and countries.

In Kuwait, despite policies that seek to replace expatriate workers with citizens in the labor market, and amid calls to realign the demographic imbalance, the country's economy continues to rely heavily on its migrant workforce. This dependence was driven home during the COVID-19 pandemic when a significant number of migrant workers left the country. The lack of foreign workers in the labor market severely impacted Kuwait's post-pandemic economic recovery efforts.

Although nearly two-third of the country's population are foreigners, and empirical evidence points to their indispensability to the economy, Kuwait is yet to address some of the challenges faced by migrants, or seize the opportunities presented by the vast number of migrants in the country. It is true that in recent years Kuwait has initiated a series of laws and policies aimed at protecting the rights of migrant workers.

For instance, Private Sector Labor Law 6 of 2010 and its amendments now govern employeremployee relations in the private sector. In 2015, Kuwait also enacted Law No 68 and Ministerial Decision No 2194 of 2016 to protect the rights of domestic workers in Kuwait. Until then, the more than 700,000 domestic workers in the country had no legal framework to protect their labor rights.

In 2017, Kuwait joined IOM as an observer state, and the IOM office in Kuwait, which was established in 1991, has worked in close partnership with Kuwait to strengthen the capacity of relevant national counterparts and ministries tasked with the protection of migrants and victims of trafficking. In 2018, Kuwait also adopted the Global Compact for Migration(GCM), indicating its commitment towards achieving safe, orderly and regular migration.

Implementation of the non-binding GCM helps states to improve the governance of migration, to address the challenges to human mobility without compromising their sovereignty. or the human rights of people, and to strengthen the contribution of migrants and migration to sustainable development in a way that increases benefits for individuals, communities and countries, and reduces its risks for all.

However, implementation of the GCM in its entirety, in both letter and spirit, has been challenging for Kuwait. For its part, the IOM organizes awareness campaigns on the topic of human trafficking and the rights of domestic workers. IOM also continues to share technical expertise with government and civil society organizations on migrant protection, and protection to potential victims of trafficking, as well as on implementation of the GCM..

By 2017, Kuwait had ratified nearly a dozen international human rights instruments and labor conventions, including on forced labor, minimum age for work, and the ILO Domestic Workers Convention. Despite the signing of multiple international covenants and treaties, as with the GCM, it is in the adoption of these international principles within the Kuwaiti national legal system, and in its implementation at the grassroot level that Kuwait has struggled.

As the UN entity for migration, the IOM has an obligation to demystify the complexity and diversity of human mobility. Misinformation and politicization of migrants and issues related to migration have often strayed far from a balanced and accurate depiction of migration. Australian ban on live sheep exports to affect Kuwait market

ustralia is to ban the export of live sheep from the country by sea from May 2028, fulfilling a pledge to end a practice long opposed by animal welfare advocates. The ban could affect the Kuwait sheep market, where there is a strong demand for live Australian sheep meat.

In a statement announcing the ban, Australian Agriculture Minister Murray Watt said, "We are giving certainty to sheep producers and the supply chain by legislating the date." The announcement makes good a commitment from the Labor government to phase out the controversial practice, despite pushback from farm groups that say the move will put people out of work and destroy farming communities.

Watt said A\$107 million would be offered as a transition package over five years to support people, including sheep farmers, affected by the industry wind-down.

The phase out does not apply to other livestock export industries, such as live cattle exports, nor does it apply to live sheep exports by air.

Australia's live sheep trade, centered in the country's vast Western Australia state, shipped about five million sheep a year in the 1990s and early 2000s, but that number has gradually declined. Last year, Australia exported 684,000 sheep, worth about \$50 million, Australian trade data show. Most sheep are shipped to the Middle East, around two weeks' sailing away. The main export destinations are Kuwait,



Israel and the United Arab Emirates.

Animal rights groups have for years pushed to end those shipments from Australia, where public outcry in 2018 over the death of 2,400 sheep from heat stress prompted calls for stricter welfare standards. In January, a ship carrying about 14,000 sheep and 2,000 cattle bound for Israel became stranded off the coast of Australia in sweltering heat after it was forced to abandon a trip through the Red Sea, causing renewed outcry from people concerned about animal welfare in the industry.

More than one million passengers passed through Kuwait Airport in April

The Civil Aviation Directorate General announced on Thursday that the total number of passengers who passed through Kuwait International Airport, last April, exceeded 1.1 million.

Abdullah Al-Rajhi, the deputy director general for aviation safety and air transport, said in a press statement that the airport had witnessed rise of the number of passengers by 11 percent, aircraft movement by 13 percent, while air cargo activity climbed by 10 percent in April, compared to last year's same month.



Al-Rajhi added that the number of arrivals, in April, reached 564,638 while those who departed Kuwait via the airport amounted to 618,242.

The number of aircraft that departed or landed at the air facility reached 10,113, compared to 8,983 in last year's April. As to the air cargo, it was estimated at 18.2 million kilograms. Destinations of top demand were Dubai, Cairo, Jeddah, Istanbul and Doha.

he world is confronting an unprecedented food crisis, exacerbated by the CO-VID-19 pandemic, Russia's war against Ukraine, and worsening climate conditions. But the problem is most acute in Africa, where 61% of the population faced moderate or severe food insecurity in 2022. And at a moment when effective solutions are urgently needed, policymakers are once again coalescing around the misguided belief that increased use of mineral and synthetic fertilizer is the key to boosting agricultural productivity and ending hunger on the continent.

This approach can be traced back to the Abuja Declaration on Fertilizer for the Africa Green Revolution that African Union leaders endorsed in 2006. The goal was to reverse the continent's poor yields by boosting fertilizer use from eight to 50 kilograms per hectare within a decade. Spearheading this effort was the Alliance for a Green Revolution in Africa (AGRA), an initiative backed by the Bill and Melinda Gates Foundation and other major donors. Working closely with large agribusinesses like the Norwegian-based chemical company Yara, AGRA championed the idea that distributing

synthetic nitrogen fertilizers would solve Africa's agricultural challenges.

But this singular focus on synthetic fertilizer use has failed to address the complex realities of farming in Africa. A recent assessment of AGRA's projects in Burkina Faso and Ghana found no evidence that providing chemical inputs and high-yield seeds resulted in increased production and higher incomes for smallholder farmers. Instead, many are now more vulnerable and indebted after coming to rely on expensive synthetic pesticides and fertilizers, the prices of which soared following Russia's invasion. These farmers have become locked in a cycle of dependency, while companies like Yara reap substantial profits.

Zambia is a good example. Despite being one of the largest consumers of synthetic beneficial microorganisms, such as mycorrhizal fungi, which are essential for nutrient cycling and plant health. When these symbiotic relationships are disrupted, soil resilience and fertility decline. According to the World Bank, Africa is already estimated to be losing around 3% of GDP per year due to nutrient depletion and general soil degradation.

In addition to undermining crop productivity, and thus dealing a devastating blow to the livelihoods and food security of millions of smallholder farmers, excessive fertilizer use also has far-reaching environmental consequences. It contributes to nitrogen pollution in water bodies, causing biodiversity loss in aquatic systems and pushing the planet past safe limits for humans. Perhaps most worryingly, research indicates that the production and application of synthetic ni-

It is true that using green hydrogen to produce fertilizer can mitigate GHG emissions. But while the production process may be less carbon-intensive, it is still highly energyintensive. And applying fertilizer can release huge surges of nitrous oxide - a potent GHG - into the atmosphere, and can still cause soil degradation and water pollution, regardless of how it is produced. By promoting "green fertilizer" as a panacea, the industry is engaging in greenwashing - using the veneer of sustainability to protect its interests.

This week, the AU's Africa Fertilizer and Soil Health Summit in Nairobi will address soil degradation and food insecurity. The involvement of industry giants like Yara and organizations like AGRA suggests continued adherence to a flawed model that has consistently failed to alleviate hunger and malnutrition, a concern shared by the Alliance for Food Sovereignty in Africa, which represents more than 200 million stakeholders. But instead of focusing on boosting short-term soil fertility, substituting one chemical with the other, and thus endorsing the fertilizer industry's selfserving narratives, the summit should consider longer-term goals, such as improving soil health and soil life, strengthening the resilience of farming communities, and ensuring the sustainability of food systems.

Productivity can be maintained without industrial nitrogen fertilizers, as shown in longterm trials across Africa. Alternatives include diversifying cropping systems, producing organic fertilizer, and planting legumes. Policymakers and stakeholders must move beyond the simplistic promotion of synthetic fertilizers, even those labeled as "green," and embrace a more transparent and evidencebased approach. Only then can we truly address the root causes of hunger and malnutrition in Africa and around the world.

nitrogen fertilizer in Africa, the country has not experienced a corresponding reduction in hunger and malnutrition. The view that more fertilizer means less hunger fails to address the systemic barriers to food security, such as affordability, and exacerbates existing challenges, such as soil degradation.

Specifically, synthetic nitrogen fertilizers disrupt the delicate balance of the soil ecosystem – the very foundation of sustainable agriculture. These inputs have been shown to reduce the abundance and diversity of trogen fertilizers accounts for roughly 2% of total global greenhouse-gas (GHG) emissions.

As a result, chemical companies like Yara are switching to 'green fertilizers', which are produced using hydrogen derived from renewable-energy sources, rather than fossil fuel-based inputs. This allows them to continue advocating for the use of synthetic fertilizers as a solution to food insecurity in Africa (and, by extension, maintaining and expanding the market for their products), even as research points to the shortcomings of such an approach.



Proteins: Proteins take a long time to be digested and do not affect your blood sugar in the way that carbohydrates do. I am not telling you to shift to a protein diet, you can have a pure protein breakfast for example if you have a long day and you will feel full.

Personally, whenever I have a long day, I try to take

for breakfast some cheese and lettuce, boiled eggs with vegetables, with a cup of skim milk. The protein will keep me satisfied longer.

Vegetables: I always tell my clients to eat their salads before their main meals, not within or after. Why? If you eat a salad with a low fat dressing at the start of every meal you will become full faster. It keeps you from eating a lot of calories at a meal as you normally would. It is low in fat, high in fiber (which gives you the satiety feeling). Chew your food well. Sometimes the simple motion of chewing can trick your brain into feeling full.

Coffee: Coffee is a natural appetite suppressant as well as a diuretic. Hot or cold, coffee is a great way to curb your appetite in the morning or afternoon. But be careful not to add cream to it. Just have it black.

Popcorn: Unlike most people I think, popcorn is a very healthy snack. It is very rich in fiber which keeps you feeling full longer. It might make you feel bloated but that is just due to its high fiber content. So whenever you feel a bit hungry, a cup of popped popcorn can be the solution.

Increase your metabolism and curb your appetite naturally.

RECIPE

Kunafa Thandai Mousse



Preparation time: 45 min. Servings: 5 to 6

A totally different take on the traditional Arabic Kunafa, this crunchy, creamy Kunafa Thandai Mousse tastes terrific and makes it an Arabic dessert fusion that is certainly worth creating.

Ingredients:

- · For Thandai powder: 2tbsp almond
- · 2tbsp cashew
- · 2tbsp pistachio
- 1 tbsp melon seeds · 1 tbsp poppy seeds
- 1 tbsp rose petals
- 1 tbsp fennel seeds
- 15-20 saffron strands 10 green cardamom
- 2 big cardamom
- 10-15 black peppercorn

For the Kunafa layer:

- 1 cup, shredded kunafa · 2 tbsp unsalted butter
- 1/4 tsp.cinnamon powder

3 tbsp sweet condensed milk

For the Thandai Mousse: 1cup whipping cream

- 1/2 cup fresh cream
- 1/2 cup chopped white chocolate 1 tsp. saffron dissolved in 2 tbsp warm water
- 4 tbsp thandai powder

For the garnish:

Chopped pistachios, few saffron threads and rose petals. **Directions:**

- For making Thandai powder:
- Blend all ingredients for powder in the mixer on pulse mode.
- Sieve the powder to extract fine powder
- Store in an airtight container

For making Kunafa layer:

Melt butter in a pan, add Kunafa shreds and roast till crispy and golden

- Add condensed milk, cinnamon powder and mix well
- Turn off the flame and remove the kunafa from pan to a bowl.

For making Thandai Mousse:

- · Pour fresh cream into a saucepan, bring to a boil on low flame immediately turn off flame. Add saffron water and chopped chocolate.
- Keep stirring until mixed evenly and no lumps of chocolate are seen.
- Keep chilled in a refrigerator until required.
- Take whipping cream in a large bowl, add thandai powder and little saffron water Whip until stiff peaks form.
- Add the chilled ganache and whip at speed one until combined well.
- Place mousse mixture in a piping bag.

Layering the dessert

- In a serving bowl or individual glasses
- Place one layer of the kunafa mix and pipe the Thandai mousse mixture on it and top it with a few drops of saffron water.
- Add another layer of kunafa mix and Thandai mousse and saffron water.
- Garnish with dry rose petals, pistachio slices and caramel almonds.
- Chill and serve.

Extreme temperatures, pollution raises risk of cardiac arrests


any people feel sluggish or experience Many people and a difficulty in breathing while carrying out routine work in extreme hot or cold conditions, or on days of heavy pollution. Now a new international study confirms that everyday activities such as lifting, carrying moderately heavy items, and walking up an incline, are significantly more taxing in extreme temperatures and pollution.

he study also suggests that the increased stress during extreme temperatures could even trigger a cardiovascular event and raise the risk of fatal heart attacks. A global analysis estimated that heat could be responsible for 490,000 excess deaths each year According to the World Health Organization (WHO), as climate change continues to worsen if no adaptation is undertaken, the heat-related excess mortality is expected to almost triple between 2030 and 2050.

A study that looked at more than 202,000 heart attack deaths in the Chinese province of Jiangsu between 2015 and 2020, noted a 'significantly associated' risk that a person would die from a heart attack if temperatures were extremely hot or cold, or there were high levels of pollution from particulate matter (PM) particles of solids or liquids in the air, such as smoke, dust, or dirt.

The study classified extremely hot weather as temperatures significantly above the average for a given area and season, consistently greater than the 90th percentile. Extremely cold weather, on the other hand, is characterized by temperatures significantly below the average for a given area and season, consistently below the 10th percentile.:

Extreme heat triggers physiological responses to help the body adapt and survive — notably, sweat and dilation of blood vessels close to the skin's surface. This causes the heart to work harder and faster to maintain adequate blood flow to vital organs, which consequently places increased workload and additional stress on the heart.



In hotter temperatures, people can also become easily dehydrated, which can increase the risk of heart attack. Dehydration can lead to a syndrome known as syncope, where a person loses consciousness due to lack of blood to the brain. Extreme heat, particularly dehydration, can exacerbate issues of syncope. Additionally, dehydration can indirectly make blood more prone to clotting, potentially leading to blockages in coronary arteries, thus triggering a heart attack.

Cold weather is also tough on the heart, but for different reasons. Cold weather induces vasoconstriction — narrowing of the blood vessels — and consequently raises blood pressure levels and reduces the oxygen supply to the heart. As your body works to keep you

warm, it adds increased stress on your heart. Similar stress is also placed on the heart under heavy air pollution

Although air pollution risks are often centered around the lungs and respiratory health, healthcare providers say it can also affect the heart, largely because the body's vital organs work together. What affects one can affect another. The WHO has recognized air pollution as a risk factor for noncommunicable diseases such as ischaemic heart disease, stroke, chronic obstructive pulmonary disease, asthma and cancer.

Clean air is fundamental to good health, says WHO. noting that 6.7 million deaths each year are attributable to exposure to ambient and household air pollution. Data from the health organization also showed that in 2021, more than 2.3 billion people continued to rely primarily on polluting fuels and technologies

PM2.5 particles are tiny particles that float in the air, risking inhalation deep into the lungs or entrance into the bloodstream. Once in the body, these particles can cause inflammation and oxidative stress, leading to damage to blood vessels and the heart. PM2.5 exposure is also associated with the development and progression of atherosclerosis — the buildup of plaque in arteries, which increases the risk of

High pollution days may be classified as those where PM2.5 levels, often measured in micrograms per cubic meter (µg/m3), exceed specific guidelines set by health organizations. According to the WHO, around 99 percent of the world's population live in places where air pollution levels exceed WHO guideline limits of annual mean concentrations of PM2.5 not exceeding 5µg/m3.

Specific cohorts of the population are at a higher risk for a fatal heart attack during extreme heat or cold or when there are high levels of air pollution. These include people with pre-existing cardiovascular conditions, like coronary artery disease and hypertension, pregnant women; people with diabetes; elderly individuals, and the very young.

However, doctors advise everyone to take precautions during extreme weather or if there is a high amount of air pollution. To protect yourself in extreme heat, experts recommend staying hydrated by drinking plenty of water; seeking shade or air-conditioned environments, when possible; modifying workouts; and avoiding peak heat, which is usually hottest between 10am and 4pm, as the risk of overexertion and stress on the heart is highest during this period.

Most importantly, listen to your body. rest in a cool place if you experience warning signs like dizziness or weakness, and seek medical help if symptoms persist or worsen.

Health benefits of climbing stairs

The benefits of exercise are well-known. from better heart health and lower blood pressure to improved emotional state. There are many ways to be active on a regular basis, from workouts at the local gym to participating in sports and games, or engaging in activities as mundane as working in the garden, doing household chores, or using the stairs.

A new study by researchers at the University of East Anglia and Norfolk, and Norwich University Hospital Foundation Trust, in the United Kingdom, show that climbing stairs is associated with improved heart health and longevity. For their study, the researchers conducted a meta-analysis, examining nine studies with 480,479 participants in total. Study participants included healthy adults ages 35 to 84 and adults with a prior history of heart attack or peripheral arterial disease.

Following the analysis, researchers found that stair climbing was linked to a 24 percent reduced risk of death from any cause and a 39 percent lower risk of death from heart disease. Climbing stairs was also associated with a reduced risk of cardiovascular events, such as heart attack, heart failure, and stroke.

The new study did not make a specific recommendation for

stair climbing frequency. However, an earlier study in 2023 had suggested that aiming for three to six flights of stairs per day assuming each flight is 10 to 15 steps — is a good goal for overall health. Another study recommended that climbing more than five flights of stairs (or around 50 steps) daily may reduce the risk of cardiovascular diseases, such as stroke, heart attacks, and blood clots.

The amount of time spent climbing stairs and the rate of engaging in this activity may largely depend on the individual's motive, whether as a form of physical exercise or from a need to remain fit. Researchers behind the new study said that the next phase of their research aims to focus on objectively evaluating the optimal number of stairs people should be climbing each day and at what intensity.

Aerobic exercises such as walking, running, biking, and swimming have been shown to help strengthen the heart and improve its ability to pump blood more efficiently, reducing the risk of heart failure.. Climbing stairs briskly is a form of vigorous aerobic exercise, which provides numerous heart health benefits. Climbing stairs is considered to be a vigorous physical activity.

Cardiovascular disease affects the heart and blood vessels. Previous studies have shown that exercise strengthens the heart muscle and improves vascular function. Other positive effects from regular exercise include improved nitric oxide production, improved vascular endothelial function, and reduced cardiovascular risk factors.

Regular aerobic exercise helps lower blood pressure over a 24-hour period, which increases flexibility in the blood vessels and reduces the risk of high blood pressure (hypertension). Exercise also increases levels of 'good' HDL cholesterol, which



helps reduce 'bad' LDL cholesterol and the risk of atherosclerosis. In addition, exercise helps regulate blood sugar and improve insulin sensitivity, which helps reduce the risk of type 2 diabetes and related blood vessel damage.

The results of this study is a reminder on the need to encourage people to incorporate more physical activity into their daily lives, and influence policy makers and health care professionals to promote physical activity, including stair climbing.

What TikTok Got Wrong About America

IkTok is now one of the biggest stories in business and geopolitics. US President Joe Biden has just signed a law that will ban the massively popular app in nine months if its Chinese owner, ByteDance, does not sell it to a non-Chinese entity.

TikTok, for its part, has called the law "political theater," and it is probably right: there is always some theatrics in politics, and bashing China is currently one of the most popular shows in town. Almost no other issue can unite the two major parties. But, given the arrogance TikTok exhibited in the weeks and months leading up to the bill's passage, the company's leadership clearly has a fundamental misunderstanding of America and Americans.

Compared to policymakers in other countries, US lawmakers are usually reluctant to regulate business, and many had previously opposed a forced sale of TikTok for fear that it could create a perception of corruption, reduce business and investor confidence, and undermine free speech. Most agree that when regulation does happen, it should clear the relatively high bar of serving the public interest.

Until a month ago, the main public-interest concern was data privacy. Questions such as who can access user data, and whether that data can be put to malign uses, are pertinent to all large social-media platforms. Over the past decade, Congress has held many hearings on the issue, often targeting large US companies such as Meta



and Google. But these concerns are amplified in TikTok's case, because many US lawmakers assume that the Chinese government can force TikTok to hand over its American users' data. Under laws China enacted in 2017 and 2021, all Chinese organizations are required to assist the government's intelligence-gathering and counterespionage work, if asked.

TikTok promised that it would store Americans' data on servers outside China. That did not satisfy US lawmakers and security officials, who continued to worry about "backdoors," an issue that contributed to the US Federal Trade Commission's decision two years ago to ban equipment made by Huawei.

Still, at one point, there was hope for a workable solution whereby US regulators would conduct detailed examinations of the company's technology. Since data privacy is an industrywide concern, TikTok could have played the

issue to its advantage, such as by investing in data safeguards and supporting independent research of its own platform. It could have met US lawmakers halfway, and approached the issue proactively, transparently, and in the spirit of collaboration. TikTok could have been a positive force for change in the US tech industry.

Instead, TikTok adopted an aggressive stance, hired expensive lobbyists, and in a catastrophic misstep, even mobilized its (predominantly young) American users to call their representatives in Congress. Pop-up messages urged users to, "Let Congress know what TikTok means to you and tell them to vote NO." Some congressional offices received more than 1,000 calls in the space of a day.

On the surface, this may have seemed like a savvy strategy, given Uber's earlier success in mobilizing its users to lobby against legislation it opposed. But TikTok overlooked a crucial

difference: Uber is an American company. By intervening in the US political process, TikTok made the situation much worse for itself, highlighting a second major threat that its critics say it could pose to the public interest.

Over the past decade, ordinary Americans and lawmakers have grown increasingly concerned about social media's undue influence on users' beliefs, behaviors, and voting decisions, and on how hostile foreign actors can exploit the major platforms for their own purposes. This risk strikes at the heart of American democracy, and it is not just hypothetical. We already know that Russia and other governments regularly try to interfere in US and European elections.

Given this context, TikTok's mobilization of its users wasn't just an annoyance to elected officials' staffers; it was an alarm bell. Many of those who responded to the call seemed not even to know what they were protesting. A foreign-owned company had brazenly demonstrated just how easy it is to manipulate its users to serve its own interests, confirming that it knew all along how much political influence it could exert. Suddenly, and understandably, the focus in the US shifted from Russian voter manipulation to Chinese voter manipulation.

Perhaps nothing could have saved TikTok from the forced-sale legislation, given the current geopolitical climate. We will never know what could have been. But it is clear that the company's aggressive strategy backfired. TikTok launched what many saw as an attack on American democracy, and ended up ensuring the majorities that were needed to push the bill through Congress.

TikTok's future in America is now uncertain. Before it weighs its next moves, the company should fire its lobbyists and consultants, who should have advised it to be more respectful of Americans' legitimate concerns about data privacy and threats to democracy. And all other non-US firms should learn from TikTok's recent missteps on what not to do.
